

INSTRUCTIONS

- 1. This Application Form should be duly filled-in and must be handed over to the interview panel during the interview.
- 2. You also need to bring at least one acceptable form of photo-identification. Acceptable forms of valid photo identification are valid Driver's license, Passport, PAN Card, Voter ID, Employee identification card, or a notarized Affidavit with Photo, Signature, Date of Birth and Residential Address.
- 3. Please affix a self attested recent passport size photograph.
- 4. NC-OBC/SC/ST/EWS candidates: Only certificates issued by competent authorities designated by the State/UT/Central Government will be considered. In case of NC-OBC category, the caste indicated in the central list (available at http://www.ncbc.in/backward-classes/index.html) of NC-OBC by the National Commission of Backward classes, GOI as on the date of written test (February 17, 2019) will be used. NC-OBC certificates should be issued on or after 1st April, 2018.

The category (i.e. SC/ST/NC-OBC) mentioned by a candidate up to the day of the written test (**February 17, 2019**) will be treated as final. Any subsequent category change request will not be entertained. **Candidates who fail to produce the required category certificate at the time of interview will not be entitled to the benefits of reservation.**

EWS candidates: EWS certificate to be submitted as per guideline No.36039/1/2019-Estt (Res) dt. 31st January 2019 of Department of Personnel & Training, Ministry of Personnel, Public Grievances & Pensions, Government of India at the time of interview.

- 5. Person with Disability (PWD) candidates are required to submit a certificate duly signed by the competent authority as per the Persons with Disability (PWD) Act. Candidates are also required to bring the original certificate for verification at the time of interview.
- 6. All the original academic certificates/mark-sheets must be produced at the time of interview for verification.
- 7. Please bring **self-attested** copies of all mark-sheets and certificates. Candidates who have already completed their graduation are advised to submit the **self-attested** photocopies of their mark sheets, degree and other certificates.
- 8. Necessary evidence (Certified record of experience or first and last pay slips) in support of work experience must be attached along with the application form and the original documents must be produced at the time of interview. Please note that Appointment Letter will not be considered as joining date in lieu of first salary slip. If evidence of work experience is not produced during the interview, the work experience will be taken as NIL.
- 9. Necessary evidence must be produced in support of extra curricular activities at the time of interview.
- 10. For computing percentages of marks in 10th or equivalent, 12th or equivalent and qualifying examination, the aggregate marks of all subjects that appear in the mark sheet/ grade sheet should be considered.

Minimum Eligibility Criteria for PGDBA:

Criteria for eligibility, shortlisting and final selection of PGDBA candidates for 2019-21 Batch

A candidate must hold a graduate/post graduate degree with any of the following:10+2+4/10+2+5/10+2+3+2 with a Minimum of 60% marks or CGPA 6.5 on a 10-point scale in the Qualifying Degree (i.e. B. Tech./ B.E./ M.Sc./ M.Com or equivalent).

For SC/ ST and Person with Disabilities (PwD) category candidates, the qualifying marks for eligibility shall be 55% or CGPA 6.0 on a 10-point scale.

The CGPA will not be converted into percentage marks, even if the degree awarding Institute provides marks in CGPA system. Their admission will be based on the CGPA awarded in the transcript. If the CGPA is on a different scale other than 10, the eligibility of the candidates will be calculated corresponding to the equivalence stated above.

Candidates, who are in the final year, are also eligible to apply provided they appear in the final examination and complete other academic requirements as specified above by May 31, 2019. For such cases, admission will be provisional subject to submission of final mark sheet by October 31, 2019.
